

Learn when the co-op is shifting and saving.

Sign up to receive text or email alerts through your SmartHub account at adamsec.smarthub.coop.

- Under "Manage Notifications," select the Shift and \$ave Signal to get an alert when the co-op is projecting an interruption to U-Shift switches.
- Select U-Shift Off-Peak Alert to receive a notification specifically for when U-Shift Off-Peak Panels are about to be interrupted.
- Follow the co-op on Facebook and X to learn specific shifting timeframes and updates.

Adams Electric makes every attempt to send timely notifications of U-Shift periods, but cannot guarantee delivery of messages.

PROGRAM INCENTIVES

**Effective 1/01/26 - 5/31/2026*

- **U-Shift Water Heating**
 - One-time \$200 installation credit for a new program sign-on
 - Monthly:
 - ◇ \$15 credit for standard electric water heaters
 - ◇ \$7.50 credit for heat pump water heaters
- **U-Shift Air Conditioning**
 - One-time \$100 installation credit for a new program sign-on
 - Seasonal:
 - ◇ \$15 credit on bills received in July, August, September and October
- **U-Shift Off-Peak Rate**
 - One-time \$500 installation credit for new program sign-on
 - Approximately a 40 percent rate reduction on power that flows through the panel
- **U-Shift Level II Electric Vehicle Charging**
 - One-time \$300 installation credit for new program sign-on
 - Approximately a 40 percent rate reduction for charging through U-Shift panel.

THE FINE PRINT: Adams Electric cannot guarantee the duration or extent of any periods of interruption due to the ever-changing nature of electrical demand on the power grid that provides power to the co-op's substations and metering points.

Members participating in the U-Shift incentives must understand that periods of interruption can be extended without notice due to unforeseen circumstances on Adams Electric's distribution system and the energy supply grid.

In 2026, to receive the one-time installation credits, members must have installation completed by May 31, 2026. The U-Shift switch must remain active through at least Sept, 30, 2026. Installation credits will be applied to the bills received in November 2026.

Members must have a fully functioning switch that is communicating with the cooperative to receive the bill credit. Members who choose to be removed from the program must return the equipment. Members will be charged for missing or lost equipment.

SHIFT YOUR ENERGY USE AND \$AVE

The co-op's U-Shift, U-\$ave program moves the use of electric water heaters, heating and cooling systems, and other interruptible equipment to off-peak hours. Help reduce expensive demand peaks which take place on the coldest or hottest weekdays by joining nearly 10,000 other members shifting their use.



U-Shift, U-\$ave Initiatives



U-Shift Water Heating encourages members to allow a switch to be installed free of charge (a \$215-value) on their electric water heaters and earn a monthly bill credit. Receive a one-time installation bill credit when a new U-Shift switch is installed on an electric water heater.



U-Shift Air Conditioning asks members to allow a switch to be installed free of charge (a \$215-value) on their heat pumps and central air units and earn a seasonal bill credit. Receive a one-time installation bill credit when a new switch is installed on a heat pump or central air unit.

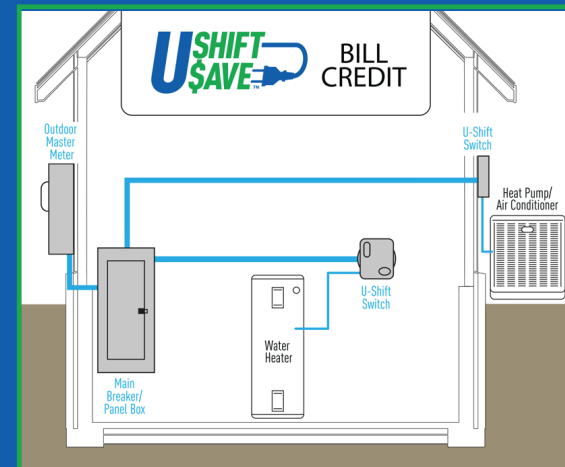


U-Shift Off-Peak Rate asks members to install a separate panel and meter base (at their expense). The co-op then provides about a 40 percent rate reduction for all the electricity that flows through that panel. Receive a one-time installation bill credit when a new panel is installed.

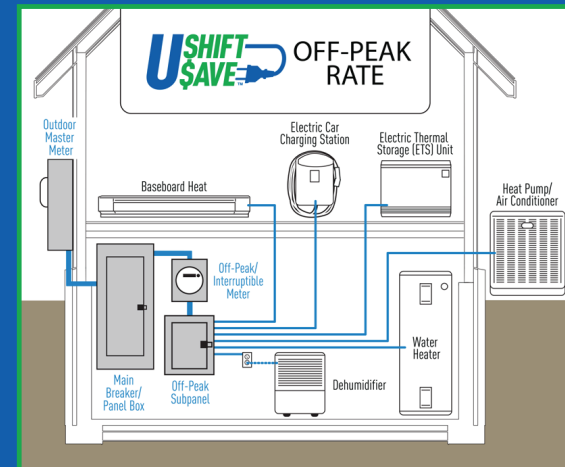
Connect a Level II electric vehicle charger to the off-peak panel and receive a one-time installation bill credit - plus the approximately 40 percent rate reduction for charging.



In general, the **U-Shift, U-\$ave** program encourages smart energy use based on the time of day when energy costs are the highest. U-Shift asks members to modify their thermostat temperature on the hottest summer afternoons and coldest winter mornings and evenings. Also, turn off or delay use of major appliances, including dishwashers, and washers and dryers. Members are encouraged to use the microwave or barbecue grill to cook their meals during those critical hours.



U-\$AVE WITH THE CREDIT: Have a U-Shift switch installed free of charge on your electric water heater, and/or heat pump or central air unit and receive an ongoing applicable bill credit.



U-\$AVE ON THE RATE: Pay to install a separately metered off-peak panel and receive about a 40 percent reduction for any electricity that runs through the panel. (The off-peak meter is installed for free by a co-op employee.) Do not connect anything to the panel that cannot have power interrupted to it.

This U-Shift switch will be installed on your electric water heater, central air unit, or heat pump. This is the cooperative's communication device during control periods.
