

## **Helping Members in Hard Times**

#### **"EVERY LIFE TRANSFORMED."**

That's the vision of New Hope Ministries, a social service agency that helps its neighbors in times of need. New Hope's unique footprint almost perfectly overlays the Adams Electric Cooperative service territory.

In late 2024, the co-op launched a Hardship Fund through New Hope that allows co-op members to receive assistance once a year as their needs warrant and as funds remain available. Serving our co-op members are New Hope centers in Dillsburg, Dover, Hanover, Littlestown, Mechanicsburg and New Oxford.

"The goal is to help our members struggling financially to get their electric account in good standing, while receiving budgeting assistance," says Rebecca Witherow, member services coordinator for Adams Electric.

New Hope's Dollars and Sense class is a basic moneymanagement course focused on increasing income and decreasing spending, and it is a requirement for any member requesting payment assistance for their bill. The class is offered about every two weeks, depending on the New Hope location.

"Our budget class is a great tool for anyone to navigate a household budget," says Alicia Roth, program assistant with New Hope. "There is always something new someone can take away from the class to apply to their budget."

The Hardship Fund is supported through donations and contributions made by members, employees, directors and the co-op to our Project Helping Hand (PHH) assistance fund. That fund is held as a pass-through account at the Adams County Community Foundation.

Those receiving assistance must be the co-op member with their name on the electric account, and the funds must go toward a member's electricity at their primary residence. There are also some restrictions on the fund distribution, such as the member must enroll in the co-op's Round Up program, which feeds back to PHH, and they cannot use the funds for fees, security deposits or meter tampering charges.

"The Hardship Fund is a huge blessing to the community of Adams Electric members," Roth says. "It's a benefit having this new program available when there may be limited resources or financial assistance in their area. New Hope Ministries is proud to administer the Hardship Fund for Adams Electric and to assist its consumers with additional resources and/or services they might not have known about."

A "four-star charity," New Hope supports its clients with food and basic needs, as well as workforce development programs, housing assistance, transportation assistance, youth programs, and financing and stability initiatives.

## NOTICE OF UNCLAIMED PROPERTY

Adams Electric Cooperative is a member-owned organization, and members as well as former members may receive retired patronage capital credits (Ownership Rewards). As a member or former member, you were provided with an Ownership Rewards check from Adams Electric in March 2024. As members move off our lines or relocate to different properties, they may have an unclaimed Ownership Rewards check of \$50 or more that was issued, but not cashed or deposited.

Adams Electric wants to ensure these unclaimed funds are paid to the rightful consumer-member before the funds are turned over to the state and then used as appropriate under applicable law. Therefore, members and former members are urged to check the list of names at *adamsec.coop* to see if we owe you money. ## **Reminder: Rates are Increasing on February Bills**

**ADAMS ELECTRIC COOPERATIVE, INC.** is committed to providing the most reliable power at the lowest reasonable cost for service. Your board of directors works diligently to minimize rate increases. To ensure the financial stability of the cooperative, your board voted in November 2024 to raise rates Jan. 1, 2025.

For the average residential consumer-member who uses 1,250 kilowatt-hours (kWh) of electricity per month and is served under rate class RES-01, this will amount to an increase of about \$9.75 a month. This 5.2% increase may be lower or higher, depending on your individual electric usage and rate classification with the cooperative.

Even with this adjustment, the co-op's rates are comparable to or below other neighboring utilities, which are experiencing much higher increases. Members are always encouraged to consider how they can reduce their own energy expenses to save on their electric bills. The cooperative offers tips for saving energy on *adamsec.coop* and can also provide printed resources on energy efficiency incentives and money-saving programs, like U-Shift, U-\$ave. The rate adjustment will first appear on your February billing statement and includes an increase in both energy supply and distribution. In simple terms, the energy charge is the cost for electricity being generated, or purchased, and delivered to the cooperative. This is directly passed through to the membership with no mark-up.

The wholesale power cost adjustment, which the co-op uses each year to re-balance the over- or under-collection of energy charges for the previous year's billed amount, is decreasing to \$0.001 per kWh per month.

The distribution charges correlate to the cost of delivering electricity from the co-op to each member home, in addition to the cost of maintaining reliable poles, wires and equipment. The monthly access charge will increase by about \$2.25 per month and reflects the costs the co-op incurs to maintain the equipment connected to your home, regardless of how much electricity you use regularly. The per-kWh charge will increase to \$0.033 per month. The storm reserve is holding steady at \$1.25 per month. @

## Director Petitions Available

Members interested in running for the board of directors may pick up a candidate petition packet at any Adams Electric office. All required paperwork must be physically received at the co-op's headquarters office in Gettysburg before the close of business on Jan. 30.

This year, the membership will elect one director each from Zones 2, 6 and 7, to help direct the business of the cooperative for the next three years. The incumbents and their intentions on running again are as follows:

**Zone 2:** Jay Herman of East Berlin is planning to run for re-election.

Zone 6: Nadine Hubner of Felton will not seek re-election.

**Zone 7:** William French of Shippensburg was appointed in July to fill an unexpired board term. He is planning to run in the election.

Winners will be announced at the annual meeting in May. Any member in good standing may run for the seat in their respective zone by completing the required paperwork. For more information on director zones or the election process, visit *adamsec.coop* or call 800-726-2324.
